Rules

- Booth Sharing: You may share your booth space with others. You need to fill out an application form for each business sharing the booth and send it to CVE.
- The show management reserves the right to exclude items from the show deemed unsuitable.
- Set up will be on Thursday, October 23rd from 10:00 - 7:00 and Friday, October 24th between 7:00 and 7:00
- Doors for the show will open at 8:00am for exhibitors on Saturday & Sunday.
- Teardown starts immediately at the close of the show (4:00 pm on Sunday). You are not allowed to teardown early. Exhibitors who close early may be subject to potential Fire Marshall & Vermont Labor and Industry penalties.
- Credentials: You will need to be wearing your credentials to be admitted to the show. Credentials will be issued at registration.
- All exhibitors are expected to fulfill all obligations of local, state and federal law.
- All tables should be covered. Empty boxes and clutter should be stored out of sight. We ask that all booths be presented in a professional manner.
- Smoking is not permitted in CVE buildings. Please use designated areas for smoking using public exits and entrances. **Do not use emergency exit doors or prop doors open at any time during show hours**
- Pets are not allowed on the Expo grounds, unless part of the show or are assist animals
- No alcohol allowed.
- Fees for rentals are non-refundable and non-transferable.
- Early cancellation of rental space is non-refundable.
